• As you can see, the way in which investments are reported has changed. The information that was provided before is still here, just in a different format. I have also included our average maturity and average yield of the portfolio which is comprised of 29 brokered CD's. I have been working closely with out broker at Fifth Third over the last few weeks to maximize our interest income going forward. As you can see, the estimated interest income is over 150% of what we earned the prior year. This number will continue to grow moving forward with rates on the rise and the number of investments increasing.

All Other Funds pg.3

• Final reporting for the FY16 grants was completed prior to our last Board meeting. We had nearly all of those grants in the red awaiting ODE reimbursements for those expenses. Those have all come in and all FY16 accounts have a zero balance.

Three Year Comparison pg. 4

- Receipts came in a bit lower than expenditures for the month. Overall we are in the black by nearly \$1.1 million for the fiscal year.
- Outstanding receivables continue to be high. This is due to the increased number of billings now that contracts have been finalized and our services are in full swing. More than half of the \$900,000 in outstanding receivables was generated in the last 30 days.
